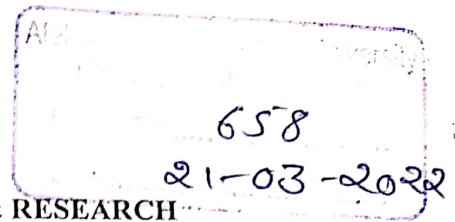

OFFICE ORDER

As per decision taken in the meeting of Prospectus Review Committee / Centralized Counseling Committee (Post Basic B.Sc. Nursing) held on 09.03.2022 under the Chairmanship of the undersigned, the vacant/unfilled Post Basic B. Sc (Nursing) seats, State and Management Quota (if any) after exhaustion of merit of Entrance Test-2021 conducted by the Atal Medical & Research University, Ner Chowk Distt. Mandi, in private Nursing Colleges (Post Basic B. Sc Nursing) of the State shall be filled up by adopting the following procedure for the academic session 2021-22 in pursuance to the Govt. approval conveyed vide letter No. HFW-B(F)11-4/2016 dated 07.09.2016:-

- i. 1st preference shall be given in order of merit of those Bonafide Himachali candidates who have qualified/appeared in the Post Basic B.Sc. Nursing Entrance Test -2021 conducted by Atal Medical & Research, University, Ner Chowk, Mandi subject to fulfillment of eligibility criteria of the Prospectus 2021-22.
- ii. In case, the seats in the State/Management Quota remain vacant even after exhausting the 1st preference, then the candidates in order of merit of GNM qualifying examination of Bonafide Himachali candidates shall be considered subject to fulfillment of eligibility criteria of the Prospectus-2021-22.
- iii. In case, the seats in the Management Quota still remain vacant even after exhausting the above procedure, then the candidates in order of merit of GNM qualifying examination irrespective of Bonafide Himachali will be considered subject to fulfillment of the eligibility criteria as prescribed in the Prospectus-2021-22.
- iv. The age criteria is strictly adhered as prescribed in the Prospectus -2021 under chapter 3 clause (c) which re-produce as under

The age of candidates should be between 17 to 35 years as on 31st December, 2021 i.e. the candidate should be born between 1.1.1987 and 1.1.2005. However, upper age can be relaxable by 5 years in the case of SC/ST candidates i.e. the candidate have been must born between 01.01.1982 and 01.01.2005. The candidates will ensure that they fulfill the above condition. Age as recorded in the matriculation certificate will be entertained

- v. It may be noted that while filling up the vacant/unfilled seats under State quota, the preference in order of merit (category-wise) shall be given to those Bonafide Himachali/Domicile

candidates who had sought admission in the private Nursing colleges under Management Quota during the Centralized counseling conducted by the Atal Medical & Research University, Ner chowk, Mandi based on the merit of Entrance Test -2021. The candidates so admitted/converted against such seats shall be charged the fee payable by the State Quota seat. The resultant vacancies of Management Quota arising due to conversion to the State Quota and other vacant/unfilled seats under State/Management quota shall be filled up in order of merit as per procedure mention at sub-clause (i) to (iv) above.

- i. For filling up the vacant seats under State/Management Quota in private Nursing Colleges as per procedure mentioned above, the interested eligible candidates may apply to the Principal(s) of the concerned Private Post Basic B.Sc. Nursing College(s) for seeking admission under State Quota/Management Quota on the Counseling-cum-Admission form (Appendix-9) which is attached in the Prospectus 2021-22 uploaded on AMRU website <https://amruhp.ac.in/> mentioning full particulars alongwith required documents latest by 26.03.2022. The counseling against vacant/unfilled seats shall be conducted by the college level on or before 31.03.2022 (which is the last cut of date for admission to all nursing programmes as prescribed by the Indian Nursing Council, New Delhi vide notification No. 1-6(LT)-2021-INC dated 23.12.2021) by the Principal(s) of the concerned nursing college(s) consisting of three members committee. In order to conduct the college level counseling, the Principals of the colleges concerned may prepare proper merit list category- wise and conduct the counseling in transparent manner by giving wide publicity amongst eligible candidates through print media /college website.
- ii. **The candidate who have not appeared in the Entrance Test-2021 conducted by the Atal Medical & Research, University, Ner Chowk, Mandi and applied for vacant /unfilled seats with the private institutions are required to be deposited prospectus fee with the institution concerned i.e. For General/OB : Rs. 2200/- For EWS/BPL/IRDP Categories: Rs. 1100/- • For SC/ST Categories: Rs. 1000/- However, the said prospectus fee is to be deposited by the College /institution concerned with the Controller of Examinations Atal Medical & Research, University, Ner Chowk, Mandi-cum-Member Secretary Centralized Counseling Committee (Post Basic B.Sc Nursing) at the time of verification of admission .**
- viii. Verification of college level counselling i.e. . Verification of eligibility criteria, original certificate/documents and physical appearance of candidate etc. shall be done by the representative of DME & R, H.P. and AMRU, Nerchowk Mandi after 31.3.2022 for which schedule will be issued separately by this Directorate / AMRU, Mandi .

Note:- 1. In case of a tie in order of merit, the inter-se ranking of the candidate(s) shall be decided on the basis of total marks in GNM course. Even, if still there remains a tie after adopting the above procedure due to equal marks or marks not specified, the candidates older in age will be given preference in case of Direct Quota candidate(s).

2. No shifting shall be allowed from one private nursing college/institution to another private nursing college/institution under the same capacity of admission. However, up-gradation

of seats i.e. Management Quota to State Quota in the same institution in order of merit is allowed.

3. The Principal(s) of Post Basic B. Sc Nursing college(s) will also check the eligibility criteria of each candidate including settlement of discrepancy(ies) as pointed out by the counseling committee as per provisions of the Prospectus before admitting the candidates in the College/Institutions.
4. In the case of candidates having passed their 10+2 examination from other than H.P. Board of School Education, Dharamsala/CBSE/ICSE, equivalence certificate issued by the H.P. Board of School Education, Dharamsala is required to be submitted at the time of counselling/admission.
5. The concerned institution will follow the COVID-19 guidelines during the course of admission of the candidates and their thermal scanning be ensured.
6. The selected candidates will have to produce a medical fitness certificate duly issued by the concerned Chief Medical Officer/Medical Superintendent/BMO/SMO of the District/Institutions as the case may be.
7. The last cut off date of admission to all Nursing programme is 31.03.2022 as per Secretary Indian Nursing Council letter No. 1-6(LT)-2021-INC dated 23.12.2021, therefore no admission shall be made after 31.03.2022 .
