Important Instructions:

1. Age :-

The minimum and maximum age limit of 18 to 45 years will be reckoned as on 01-01-2022. The upper age limit is relaxable by five years for candidates belonging to Scheduled Caste, Scheduled Tribe and Other Backward Classes & Children/Grand Children of Freedom Fighter of Himachal Pradesh. The upper age relaxation is also available to Ex-Serviceman candidates of H.P. as per provisions of relevant rules/instructions of H.P. Govt.

2. Reservation :-

The benefit of reservation for various post(s) will be admissible only to the applicants, who are Bonafide residents of Himachal Pradesh in respect of categories, viz. SC., ST, OBC, EWS, BPL/IRDP, Ex-Serviceman and WFF etc. No change of category shall be allowed after receipt of application, i.e., from SC to OBC/ST etc.

The category of the candidate claimed in the application form for the post shall be treated as final **S.C’s** of H.P./**S.T’s** of H.P./**O.B.Cs’** of H.P. and Ex-Servicemen of H.P. applicants must possess such certificate(s) in support of their claims made in the application(s), while applying for these posts. All the applicants belonging to reserved categories are also required to go through the relevant instructions issued from time to time by the Government of Himachal Pradesh, in order to ensure that they are eligible under a particular category.
