The Application through online mode are invited from Bonafide Himachali Foreign Medical Graduates who have qualified Foreign Medical Graduate Examination conducted by National Board of Examinations in Medical Sciences, New Delhi for Compulsory Rotatory Medical Internship in Government Medical Colleges affiliated with Atal Medical and Research University, HP for the session 2024-25 . 1. The seat allocation shall be done through centralized Counselling strictly on the basis of merit drawn on the basis of marks of Foreign Medical Graduate Examinations being conducted by National Board of Examinations in Medical Sciences, New Delhi-cum- choice of College filled-up by the candidates in the online application form.
2. If the marks obtained in the NBE exam are same, the candidate who appeared in NBE exam on an earlier date shall be placed higher in the merit.



3. If both the above criteria are same, the candidate born earlier shall be placed higher in merit.
4. A combined merit list of all applicants and separate merit list of Himachali Bonafide & Non-Himachali applicants shall be prepared.
5. Preference will be given to Bonafide Himachali candidates if seats remain vacant they will be offered to Non Himachali candidates.
6. The duration of internship will be decided by H.P. Medical Council, Shimla after seat allocation.
7. The Bonafide Himachali Foreign Medical Graduates who are already doing internship in State Medical Colleges need not apply, for 2nd year / 3rd year duration of internship as they shall continue in the same place till completion of their required Internship duration.
8. At present there is no provision for stipend to FMG in Govt. Medical Colleges. However, the Government of HP shall decide on the issue of provision of stipend to FMGs.
9. The Candidate will be required to register with H.P. Medical Council Shimla before joining the allocated college. The candidate shall report to the allocated colleges with Provisional Allocation letter and Provisional HPMC registration letter and other original documents, on or before 15.05.2024. If the candidate does not report by 15.05.2024 to the allocated college, the seat shall be offered to the next candidates of merit.
10. If the candidate allocated seat does not join the college, he/she will be removed from the list and will not be offered any seats.
11. The Online application fees shall be Rs.5000/-
12. The seat allocation list shall be displayed on AMRU website 6.05.2024.
