This is in continuation of our notice no. AMRU/(COE)-Admission-80/2024-25-PG (MD/MS) 5594-604 dated 12.08.2024 it is informed to all In-Service (GDO) candidates who want to participate in PG (MD/MS/DNB) counseling 2024 of H.P that the mandatory service and In-service incentive shall be calculated till declaration of Neet-PG-2024 result i.e 23, August 2024. So candidates are directed to get their incentive certificate immediately from the Director of Health Services, HP through CMO/BMO/MS.

This Incentive Certificate shall be valid only for appearing in the State Quota of Common/Centralized Counseling. It would be mandatory to upload the Mandatory Service/Incentive Certificate at the time of filling of online application form for counseling 2024. Forms without Mandatory/ Incentive Certificates may be summarily rejected. Additionally, no incentive certificates will be accepted after the closing date of the online application form for that round.

The formula for calculating mandatory service in the notice dated 12.08.2024 may be read as:

$$\text{Mandatory Service Period for a particular fieldposting} = \frac{\text{Duration served (in days) } \dots\dots\dots}{\text{Prescribed Mandatory Service (in years) * 365}}$$

If the total of all the category of areas adds up to one or more the candidate shall be eligible for the State Quota seats.
