Other conditions for affiliation of AMRU:

1. New Applicant College shall request for creation of new applicant college login id through email to the Academic Branch of university in "**acadmedicaluniv.mandi@gmail.com**".
2. The process of affiliation, payment of Application, Affiliation and Inspection Fees shall be done through IUMS portal of University. Applicant College should visit <https://erpamruhp.in> and follow the path **Head Admin>Academic Audit->Academic Audit Report**.
3. College is required to submit the complete application form on IUMS portal of the University along with prescribed fee, failing which, application will be rejected straight way.

4. After receiving the online application for affiliation (complete application), the same will be processed by AMRU to grant the desired affiliation as per provisions of *Atal Medical and Research University, HP regulations for Affiliation and Inspection of Colleges*
5. Application fee for seeking Temporary/Provisional Affiliation to be charged from applicant colleges for each course is non refundable.
6. All colleges have to follow the Ordinance/statutes of the university. No affiliated institution shall be allowed to discontinue any course without prior approval of the University as per *Atal Medical and Research University, HP regulations for Affiliation and Inspection of Colleges*. An application for such approval shall be made to the Registrar, AMRU by the Head of the Institution duly forwarded by the Management at least one full academic year in advance, giving the reason in support of the proposal & resolution of managing body for closure be enclosed.
