- 2. The award shall be made in cash to the meritorious students of MBBS course, who ranks first in the overall merit of MBBS examination conducted by AMRU, H.P.
- 3. Cash prize shall be made out of the interest amount of endowment fund to be maintained in the shape of FDR. FDR shall be made in the favour of Finance Officer, AMRU. In future funds can be added to the endowment fund.
- Initially the endowment fund shall be maintained with an amount of Rs. 100,000/-(One Lakh only) to be donated by Prof (Dr.) Surender Kashyap, Vice-Chancellor, AMRU, H.P.
- Endowment fund shall be maintained in the bank providing highest rate of interest, for which new bank Account shall be opened. Bank Account shall be operated jointly by Registrar and Finance Officer, AMRU, H.P., Finance Officer shall be the custodian of the fund.
- 6. In addition to cash prize a certificate shall also awarded annually on a suitable date which shall be decided by the University authority.
