Item No. 6.5:

To discuss and approve the revised regulation for B. Pharmacy (Ayurveda), Scheme of teaching and examination & syllabus as approved by the Dean, Faculty of Indian System of Medicine, AMRU, H.P

The Dean of Academic Affairs, AMRU, H.P informed that members of the council about the regulation for B. Pharmacy (Ayurveda), Scheme of teaching and examination & syllabus as approved by the Board of Studies. He further informed the members that revised regulation for B. Pharmacy (Ayurveda), Scheme of teaching and examination & syllabus was prepared and University will adopt it, and these regulation for B. Pharmacy (Ayurveda), Scheme of teaching and examination & syllabus was prepared and University will adopt it, and these regulation for B. Pharmacy (Ayurveda), Scheme of teaching and examination & syllabus was applicable for all student studying in B. Item No. 6.6: To seek approval for Post Graduate Medical Education Regulations, 2023 (PGMER, 2023).

The Dean of Academic Affairs, AMRU, H.P apprised the members that Post Graduate Medical Education Regulations, 2023 will be adopted by the University and were placed before the Hon'ble members for their kind consideration & approval. After detailed deliberation the item was approved by the Academic Council.

Item No. 6.7: De-affiliation of B.Sc Renal Dialysis in IGMC for academic session 2023-24, due to non-availability of teaching staff for concerned subject.

The Member Secretary apprised the members of the council that as per the recommendation of scrutiny committee constituted for B.Sc Medical Technology course for academic session 2023-24 held on 08.12.2023 the affiliation of B.Sc Medical Technology (Renal Dialysis) in IGMC Shimla may be discontinued because there is no eligible faculty to teach the students of these courses. The Dean of Academic Affairs, AMRU, H.P also agreed and informed that no new admissions will be done in this course but the students already admitted will continue. He also expressed concern that there should be some provision for teaching the students already admitted in this course. He informed that this matter has been discussed in the meeting of Prospectus Review Committee and that committee is also recommending to discontinuing this course.

Dr. D.K Verma, Principal, SLBSGMC&H, Mandi, H.P informed that these students should be either trained by Nephrologist or by the faculty of medicine who has exposure in dialysis. Dr. Surinder Singh, Prof. & HOD, Anesthesia, IGMC, Shimla & Dean of Faculty of paramedical Sciences AMRU, H.P informed that these students should be transferred to Dr. RPGMC&H, Tanda, Distt. Kangra, H.P as the facilities for teaching these students are available there. After detailed deliberation, it was decided by the members that training of admitted students will be discussed with the Govt.

Item No. 6.8: To seek approval for AMRU MBBS Course Regulations 2023.

The Member Secretary apprised the members that university has prepared AMRU, MBBS Course Regulation, 2023 as per the NMC guidelines for the students. These regulations are approved by UG Medical Board of Studies, AMRU, H.P The Academic Council considered the item and after detailed discussion approved the AMRU MBBS Course Regulations, 2023.

Item No. 6.9:

To seek ex-post facto approval for Inspection for the PG courses i.e. MD/MS/MDS/MD-Ayurveda running in all the Govt./Private colleges/institutions affiliated under AMRU, Nerchowk, Distt. Mandi conducted only at the start of the course and end of the course. Example: Academic Batch 2021-22 (Start of the course) and 2024-25 (End of the course).

The Member Secretary apprised the members of the Council that MD/MS/MDS/MD-Ayurveda running in all the Govt./Private colleges/institutions affiliated under AMRU, H.P are three year courses, it is proposed to conduct the Inspection for these PG courses only at the start of the course and end of the course. The Dean of Academic Affairs, AMRU, H.P informed that there is no change in the minimum requirements in first and second year of these courses so there is no need of inspection in the second year. The same policy is followed by NMC who conducts inspection before start of the course and at the time of examination of first batch. After the detailed deliberation the item was approved by the Academic Council. Since these courses are being run since academic session 2021-22, ex-post facto permission is also approved for these batches.

Item No. 6.10: To seek ex-post facto approval for MD/MS/MDS/MD-Ayurveda courses one Application fee to be charged at the time of the start of the course and inspection fee to be charged only when the physical inspection to be conducted.

The Member Secretary informed the members of the Council that as explained in item 6.9 MD/MS/MDS/MD-Ayurveda are three year courses and no inspection is conducted in second year so no inspection fee will be charged in second year. This proposal is in compliance of a general rule that the inspection fee is to be charged only when the inspection is conducted. It is also proposed that Application fee for any course is to be charged only at the time of the start of any course i.e. at the time of Provisional Affiliation and not every year. The Academic Council considered and approved the same. Since these courses are being run since academic session 2021-22, the approval shall be applicable for all the batches ex-post facto.

Item No. 6.11: To ex-post facto approval for one application fee and one inspection fee to be charged for B.Sc Paramedical courses annually.

The Member Secretary apprised the members that in Paramedical Courses there are more than one subject in which the degrees are awarded but there is only one application form and inspection is also done by only one team. It is proposed that only one application fee & one inspection fee is to be charged for B.Sc Paramedical Course irrespective of number of subjects annually. Since the courses are already

running so after thorough deliberation, the members of Academic Council approved the agenda item ex-post facto. It was decided that in future the regulations for affiliation will be implemented as approved.

Item No. 6.12: To seek approval for condonation of late fee on account of affiliation of various courses for the Academic Sessions 2022-23 and 2023-24.

The member Secretary apprised the members that the Audit Department has raised a query regarding non-collection of late fee on account of affiliation of various courses for the Academic Session 2022-23 and 2023-24. He further informed the members that as per University Ordinance there is a provision for late fee, but University has not invoked the clause w.r.t to late fee for academic session 2022-23 & 2023-24 due to Administrative reasons. Further, he also informed that late fees for academic session 2021-22 was convened by Academic Council due to COVID. After discussion, the item was approved by the Academic Council & will be placed before the Finance Committee for further approval.

Item No. 6.13: To seek ex-post facto approval for adjustment of excess amount received from various Govt./Private Colleges/Institutions.

The Member Secretary apprised the members of the Council that excess amount received from various Govt./Private Colleges/Institutions to be adjusted by the University in future payments. After detailed deliberation, the members of Academic Council approve the agenda item & will be placed before the Finance Committee for further approval.

Item No. 6.14: To seek ex-post facto approval for Govt./Private colleges/institutions regarding affiliation with AMRU, HP only for single Academic batch shall deposit all the affiliation related fees starting from the 01st year to the end of the year.

The Dean of Academic Affairs, AMRU, H.P informed the members of the Council that for Govt./Private colleges/institutions willing to affiliate with AMRU, HP only for single Academic batch shall deposit all the affiliation related fees starting from the 1st year to the last year of the batch. He further informed that this issue arose as Govt. directed AMRU, H.P to take over the nursing batch of a particular college. He further emphasized that University has to conduct exams every year for the affiliated batch and has to also look after other requirements of the batch. So the affiliation fees is required every year. After detailed deliberation the Academic Council approve the same.

Item No. 6.15: To seek approval for one inspection for the nursing institutions that are running more than one nursing courses.

The Dean of Academic Affairs, AMRU, H.P apprised the members of the Academic Council that for nursing institutions running more than one nursing courses there is single application form and inspection is conducted by a single team in a single visit so only one inspection fee will be charged irrespective of number of nursing courses i.e. Basic B.Sc., Post-basic B.Sc. and M.Sc.. After detailed discussion, this agenda item was approved by the academic council ex-post facto for all the batches. It was decided that in future the regulations for affiliation will be implemented as approved.

Spot Agenda Items

Item No. 6.16:

To seek approval for Affiliation to be granted in respect of IGMC, Shimla for on-going DM/M.Ch courses for Academic Session 2021 onwards.

The Member Secretary apprised the members that affiliation to be granted in respect of IGMC, Shimla for on-going DM/M.Ch courses for Academic Session 2021 onwards. The Dean of Academic Affairs, AMRU, H.P informed the members that IGMC, Shimla is running super speciality courses namely DM (Neuro-Surgery), DM (Cardiology), DM (Gastroenterology), M.Ch (CTVS) affiliated with H.P.U, Shimla. As per the enactment of the Himachal Pradesh University of Health Sciences Act, 2017 all Medical Courses should be affiliated with AMRU and University is affiliating Medical Courses from 2020. Now we have received communication from IGMC as directed by Govt. to issue necessary circular/guidelines for the affiliation of on-going DM/M.Ch courses. He further informed that AMRU has no objection to affiliate the above mentioned DM/M.Ch courses from the Academic batch 2021, but inspection will be conducted for the session 2023-24 and affiliation for the Academic Session 2021-22 & 2022-23 will be granted on the basis of inspection to be conducted & Affiliation fees to be submitted for all the years i.e. 2021-22, 2022-23 & 2023-24. After detailed deliberation, it was decided that NMC will be apprised of the affiliation of DM (Neuro-Surgery), DM (Cardiology), DM (Gastroenterology), M.Ch (CTVS) with AMRU, H.P from the academic session 2021-22.

Item No. 6.17: To seek ex-post facto approval to charge annual affiliation fees for the Academic Session 2023-24 and relaxation of Application, Inspection & Certificate fees w.r.t above mentioned session for the Batch of 2021-22.

Item No. 6.18: To discuss & approve minutes of Board of Studies for PG Courses (MD/MS) for uniform pattern of examination and syllabus of various specialities.

The Member Secretary placed before the Hon'ble members of the Academic Council the minutes of meeting of Board of Studies for PG Courses (MD/MS) for uniform pattern of examination and syllabus of various specialities. After detailed discussion the item was approved by the members of Academic Council.

Item No. 6.19: To approve final examination result of Post Basic B.Sc Nursing and M.Sc Nursing students for Academic session 2022-24

The Registrar shall, after the approval of the Vice-Chancellor, from time to time, report to the Academic Council the names of all persons who have passed the various examinations qualifying them for admissions to the degrees of the University. When the Academic Council has sanctioned the admission of any such person to such degree, he/she shall be entitled to be formally admitted to that degree. The date of formal admission to a degree shall be the date on which the Academic Council has sanctioned the admission of any such person to such degree.

Further, Member Secretary placed the agenda item & after detailed deliberation the member of the Council approved the same.

Item No. 6.20: To impart training to dealing assistant of all the concerned Colleges regarding various information & activities to be uploaded on IUMS Portal of the University.

The Member Secretary apprised the members of the Council that University constantly receives communication from various Colleges w.r.t functioning of IUMS Portal of the University. He further proposed the idea that a physical training session will be organized by the University with respect to IUMS Portal. After detailed discussion it was unanimously decided that training will be organized and date will be inform to colleges.

Item No. 6.21: Regarding B.Sc Nursing admission.

The Dean of Academic Affairs, AMRU, H.P apprised the members of the Council that the directions were given by the Govt. of H.P to the Counselling Committee to admit B.Sc Nursing students on the basis on their 12th marks who did not appear in entrance exam. He further informed that INC has refused to approve the admission of students who were admitted in B.Sc Nursing Course for the Academic Session 2023-24 without Entrance Exam. It was informed by the Dean of Academic Affairs, AMRU, H.P that a total number of 333 such students were admitted in different private colleges of the state on the directions of Govt. of H.P. After detailed deliberation it was decided that a letter may be written to Govt. of H.P regarding this matter. Further, it was also decided that the Govt. of H.P may be requested to raise the matter with the INC to consider approving of these admissions as a one-time measure. It was also decided that till the final decision is taken by INC, the semester exams of these students may be conducted as per schedule of their batch.

Item No. 6.22: Regarding Syllabus of BAMS approved by Board of Indian System of Medicine.

The Dean of Academic Affairs, AMRU, H.P apprised the members of the Council about the syllabus of BAMS course approved by Board of Studies of Indian System of Medicine. After detailed discussion the item was approved by the members of Academic Council.

Item No. 6.23: Regarding re-evaluation of answer sheets.

The Principal, Himachal Dental College, Sundernagar, Distt. Mandi, H.P requested that there should be the provision for re-evaluation of answer-sheets if requested by a candidate. The Dean of Academic Affairs-cum-Controller of Examinations AMRU, H.P informed that in dental sciences every paper has more than one parts, which are checked by different examiners, in the end the total marks are calculated. Thus, every
