This is for information to all candidates who are interested in taking admission in the B.Sc. Medical Technology course for the academic session 2025–26 that, as per the Government of India, Ministry of Health and Family Welfare, National Commission for allied and Healthcare Professions, Notification No. F. No. Z/58/2024-AHS-DOHFW, dated 24.04.2025 and curriculums released by NCAHP on dated 23.04.2025 the following changes have been introduced:

- 1. The existing B.Sc. Medical Technology (Radio-diagnosis & Radiotherapy) degree has been divided into two separate degree programs:
  - B.Sc. Radiology & Imaging Technology
  - o B.Sc. Radiotherapy Technology
- 2. The duration of the B.Sc. Medical Technology course is now 4 years (3 years academic + 1 year internship) instead of 3 year of course.

These changes may be implemented at a later stage, during the counseling or during the academic session 2025–26, if decided by the competent authority.

All prospective candidates are advised to take note of this while applying for admission.

- 1.1 For the session 2025-2026 Atal Medical and Research University, HP, Mandi at Ner Chowk will conduct a Combined Entrance Test on behalf of Government of Himachal Pradesh for admission to the B. Sc Medical Technology Courses which are available in Indira Gandhi College, Shimla and Dr. R.P. Govt. College, Kangra at Tanda, and B. Pharmacy (Ayurved) Course that is available in College Of Ayurvedic Pharmaceutical Sciences Joginder Nagar Distt. Mandi (H.P.)
- 1.2 The desirous candidates may submit a common application form for these courses in online mode.
- 1.3 Indira Gandhi Medical College, Shimla, Dr. R.P. Govt. College, Kangra at Tanda and College of Ayurvedic Pharmaceutical Sciences Joginder Nagar, Distt. Mandi (H.P.) are affiliated to Atal Medical & Research University, Mandi.

### **Chapter 2**

# Eligibility, Educational Qualifications and other Conditions for Admission

- 2.1 ELIGIBILITY FOR DIRECT CANDIDATES FOR B.Sc. MEDICAL TECHNOLOGY AND B.PHARMACY (AYURVED)
- 2.1.1 Applicant should be children of Bonafide Himachali or Children of Himachal Govt. employee and employees of autonomous bodies wholly or partially financed by Himachal Pradesh Government. They will only be eligible to apply for competing for admission to Medical Courses through entrance test.
- 2.1.2 For Medical Technology Course the candidates must be in the age group of 17 to 25 years on 31.12.2025. However, 5 years relaxation on upper age limit shall be available for reserved category candidates as per State Government reservation policy. Candidates should have passed the qualifying examination before taking entrance test for Medical degree courses.
- 2.1.3 For B. Pharmacy (Ayurved) Course The candidate should have attained an age of 17 years and must not have completed 24 years of age as on 31<sup>st</sup> December 2025. However, the relaxation of five years in the upper age limit shall be applicable to SC/ST/OBC/PwD/ Family of Freedom fighters of Himachal Pradesh. Date of Birth as recorded in Matriculation/Higher Secondary Certificate Part-I/Indian School Certificate will only be valid.
- 2.1.4 The candidate should have duly qualified the examination 10+2 course of a recognized university or board with Medical stream for B.Sc Medical Technology course and both Medical & Non-Medical stream for B. Pharmacy Ayurved Course with 50% marks for General candidate and 40% in case of SC, ST & OBC candidates.
- 2.1.5 Eligibility Criteria For Physically Handicapped (Benchmark Disabilities) Persons having benchmark disabilities are entitled for reservation under the Rights of Personswith Disability Act, 2016. The candidate must possess a valid documents certifying his/her physical disability as per CCIM guidelines pursuant to judgment of Hon'ble Supreme court ofIndia i.e. one category viz physically handicap with locomotors disorders and that to with disability of lower limbs between 50% to 70% failing which 40% to 50%. The disability certificate should be produced on prescribed form attached as Appendix-8 by a duly constituted and authorized medical board of the State or Central Govt. Hospital/Institution and should be issued within 3 months prior to presenting his application for seeking admission in the course by claiming the benefit of reservation.

Candidates eligible for this category are advised to ensure their eligibility by getting themselves examined as per criteria laid down in the aforesaid Appendix of the prospectus from a duly constituted and authorized Medical Board of the Indira Gandhi College & Hospital, Shimla or Dr. Rajendra Prasad Govt. College & Hospital Kangra at Tanda. Candidates are required to obtain the Disability Certificate as per Appendix-(8 A) within three months prior to 1st round of counseling for seeking admission to B. Sc Medical Technology Courses for claiming the benefit of reservation as per requirement of the prospectus.

- 2.1.6 Economically Weaker Sections (EWSs) means the persons who fulfilled the criteria as prescribed by Government of Himachal Pradesh Department of Personnel (AP- III) vide letter No. PER(AP)-C-B(12)-1/2019 dated 11.06.2019. As per aforesaid letter, the persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 4.00 lakh (Rupees Four lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income;
  - a) More than 1 hectare; of Agriculture Land in rural areas and 500 M2 land inurban areas;
  - b) Residential flat/ house of more than 2500 square feet in rural/ urban areas;
  - c) Family of income tax payee;
  - d) Family of Regular/ Contract employees of the Central Government, State Government, Board, Corporation and autonomous bodies and Public Sector Undertakings etc.

### 2.2 For Medical Technology Course, Eligibility Criteria for In-Service Candidates Serving The Health & Family Welfare Department & Ayurveda Deptt. of the State of Himachal Pradesh only

Note: In-service candidates shall be allotted seat by counselling committee bases on the seniority of concerned department. These candidates need not appear for entrance examination.

### 2.2.1 Educational Qualification:

(i) In-service candidate must have passed matric with science examination from any recognized Board and having Diploma/ Certificate course in the concerned specialty (Lab. Technicians/Assistant, Radiology, OTA) awarded by DHS or DME in which the applicant intends to compete and having minimum 10 year's experience in Govt. Service in the Health & Family Welfare Department & Ayurveda Deptt. of Himachal Pradesh.

OR

(ii) Must have passed 10+2 examination of any recognized University/ Board with Science

i.e medical group (Physics, Chemistry, Biology) with 5 years' experience in Health & Family Welfare and Ayurveda Deptt.of H.P. in concerned specialty in which the applicant intends to complete.

OR

(iii) All the interested In-Service candidates promoted from the post of Laboratory Assistant to the post of Laboratory Tech. who have passed Matric with Science examination from any recognized Board and having minimum 10 year's experience as Laboratory Tech in Govt. Service in the Health and Family Welfare department and Ayurveda Deptt. of H.P shall eligible to appear in the Entrance test.

NOTE: In-Service candidates of Health & Family Welfare and Ayurveda Deptt. Who possess Matric qualification besides having diploma /certificate course in Radiology awarded by DHS and DME, H.P. are not eligible to get admission in (Radio-diagnosis and Radiotherapy) course. However, if in-service candidate who possess 10+2 qualification Physics. Chemistry and Biology besides having diploma/certificate course in Radiology awarded by DHS /DME are eligible to get admission in B.Sc. (Radio- diagnosis and Radiotherapy Tech.) course. There should be upper age limit of 45 years as on 1st January 2025

### 2.2.2 **Application Form:**

The application form of B.Sc. Medical Technology Course in-service candidate should be routed through the Director, Health Services, H.P./ Director of Ayurveda H.P. to the COE, Atal Medical & Research University, Mandi at Ner Chowk before declaration of result of Combined Entrance Teat along with NOC and a certificate verifying the length of service.

#### 2.2.3 COMPETITIVE TEST FOR IN-SERVICECANDIDATE:

In-service candidates shall be allotted seat by counseling committee based on the seniority of the candidate. These candidates need not appear for entrance examination.

- 2.3 If no PwD, WFF or any other category candidate applies or if the candidates are found ineligible, these seats may be converted to UR main/ respective main/ category before the start of the counselling/in the 1<sup>st</sup> round of the counselling.
- 2.4 Gerneral IRDP/BPL candidates may also be considered for EWS Seats in Government College but at the time of admission, candidates must produce EWS certificate

### GUIDELINES FOR COMPLETING ONLINE APPLICATION FORM:

### 4.1 Registration

Candidates are advised to use Laptop or Computer along with the latest registered version of Chrome/Internet Explorer/Firefox/Windows/IOS during the Registration and Choice-Filling process to avoid any technical complications

### 4.2 Fill-up all Required Details

#### 4.2.1 Personal Details

The candidate should fill each column of the online application form carefully in order to avoid any error.

The candidate should fill her name, father's name, and date of birth exactly as per matriculation certificate. Any variation may lead to cancellation of the candidature whenever discovered.

The information supplied by the candidate especially relating to DATE OF BIRTH, CATEGORY, STATE OF DOMICILE, EXAMINATION CENTRE and QUALIFICAION shall be treated as final and no change shall be allowed to be made in this regard at a later stage. The applications shall be scrutinized strictly according to the information supplied by the candidate and the responsibility with regard to the accuracy of the information shall lie with the candidate herself. The particulars to be filled in the online application form are as under:-

#### 4.2.2 Candidate Photograph and signature

Photograph should be taken on or after 1 st June 2025 upto the size of 40kb.

- -The focus needs to be on face (80% face coverage, ears clearly visible, on white background).
- -Spectacles are allowed only if being used regularly.
- -Photograph should not be with cap or goggles.
- -The candidate should put his full signature in running hand writing on white paper [not in capital letter] with Black ink pen and scan for uploading upto the size of 20 kb.

- -Photo & Signature must be clearly visible and must be in \* .JPEG/\*.JPG format.
- -Uploaded Photo and signature will be used in pre and post examination processes i.e Registration Card, Examination form, Re- evaluation form, Admit Card, Cut-lists, Degree etc.

### 4.5 Final Submission and Downloading the Pdf.

- **4.5.1** Before submitting the application form online, shall satisfy her eligibility to appear in the test. Candidate is required to go through the Prospectus carefully and acquaint herself with all requirements with regard to submission of online Application Form.
- **4.5.2** Only payment of fee shall not be considered as submission of application. After payment, the candidate should require to submit the online application form by click on "**Final Submit**" button and download pdf of Application form.
- **4.5.3** Your application form and download pdf on final submission of Admission form, you will **not be able to edit** any entry.
- **4.5.4** The candidates may, please note that the Admit Cards for the Entrance Test will not be sent by post and the same will be downloaded by them from University website or login.
- **4.5.5** Under no circumstances will candidates be permitted to change their category or any other details in the application form. If a candidate wishes to make any changes, they must submit a fresh application form with a new email address. Candidates are required to inform AMRU to disapprove their previous online application form but application fee shall not be refunded or adjusted

### 4.5.6 Print out of Computer-Generated Application Form/ Confirmation page

The print out of the Online application form will be retained by the candidate and the same shall be submitted at the time of Counseling/ admission. Therefore, it will be the entire responsibility of the candidate concerned to supply correct and authenticated information on the online Application form. Application Forms not accompanied with "Fee Details" shall be

treated as incomplete and will be summarily rejected without assigning any reasons. The Application Form of ineligible candidates will also be rejected. After the last date of receipt of the print out of the online application form, no request for change of category and examination centre once opted/filled in the application form will be entertained under any circumstances. It is further clarified that the candidates are allowed to appear in the entrance test provisionally and shall be taking the test at their own risk and responsibility as far as their final eligibility is concerned, the University shall, in no way be responsible, if they are found to be ineligible later, leading to cancellation of their result/merit or any other consequence emanating from the same. The final scrutiny of the application form with reference to original documents will be done at the time of counselling/admission by the Counselling Committee. The Principal of the college concerned before admitting the candidate to the course shall also check the final eligibility of each candidate as per the provisions of the prospectus. Any wrong or misleading entry or documentation in the form will lead to the rejection of the candidature at any stage without assigning any reason for which the candidates(s) would be solely responsible.

- 4.6 No representation beyond the provisions of the prospectus shall be entertained or replied thereof. However, for any correspondence, the candidate must quote her Application Form No., Roll Number, Name and Father's Name with full address.

# Chapter 5 DETAILS OF ENTRANCE EXAMINATION

- 5.1 The admission will be made on the basis of merit of the Entrance Test to be conducted by the Atal Medical and Research University, HP on the schedule date mentioned in the prospectus. The name and address of the examination center will be communicated on the admit cards to be made available on the University website www.amruhp.ac.in for appearing in the Entrance Test. Examination Centre once opted by the candidate will not be changed. However, University reserves the right to allot any centre in view of exigencies.
- 5.2 Admit Card: The University will provide the facility of downloading the Admit Cards for appearing to Combined Entrance Test-2025 (For B.Sc. Medical Technology and B. Pharmacy, Ayurved) on the University website www.amruhp.ac.in. The candidates are required to download the Admit cards from the website by following the instructions/schedule given therein. The candidate may please note that Admit cards will not be sent by post. The Admit cards uploaded on website will be provisional and does not entail the eligibility of the candidate for admission to the course. The Admit Card will bear the Roll Number, Name, Father's Name, Category, Photograph, Date, Time, Venue of Entrance Test. The candidate should carefully examine the Admit Card downloaded by her for all the entries made therein. In case of any discrepancy, the candidate should immediately inform the University. In such cases, candidates would appear in the examination with the already downloaded Admit Card. However, the University will take necessary action to make correction of factual error in the record later. No candidate will be allowed to sit in the test without having Admit Card and the University will not be responsible on this account. The candidates are advised to preserve their Admit cards in good condition till the admission process is over.
- 5.3 **Syllabus & Pattern of the Entrance Examination:** The Entrance Test shallconsist of one written paper only in the subjects of Physics, Chemistry (including Organic Chemistry) and Biology in accordance with the syllabi of studies based on NCERT books of the academic session according to which the 10+2 (includes 11th and 12th classes) examination. The medium of examination shall be English. The question paper will have 100 (One Hundred) MCQ objective type questions of one mark each. Each question will have four options i.e. A, B, C & D. Out of which only one will be the correct option. The duration of Entrance Test will be 2 hours. There will be no negative marking for incorrect answers. The question paper will be in English language only of the following subjects:-

# Chapter 6 DECLARATION OF RESULT AND MERIT LIST

- 6.1 The minimum qualifying marks of the entrance test for admission to B.Sc. Medical Technology course shall be 50% for General Categories, and 40% for Scheduled Castes/Scheduled Tribes and Other Backward Classes and Physically Handicapped candidates.
- 6.2 Before declaration of result, the key answers as provided by the Examiner(s) will be displayed on University Website. If any candidate is not satisfied with the answers, he/she would be allowed to make representation with documentary proof to the COE, Atal Medical and Research University, HP, at Nerchowk, Distt. Mandi, HP-175021 in person or through email: counselling.amruhp@gmail.com within a period of two days or as specified in the notification, and thereafter no representation will be entertained under any circumstances. The said representations will be referred to the Moderation Committee of subject expert to be constituted by the Vice- Chancellor, for their consideration and recommendations. The decision/recommendations of the Moderation Committee shall be final and binding upon all concerned. The Committee will also be authorized to take suo moto notice of any error in the question paper. If the committee feels that the key answers as provided by the examiner is not proper, it will be taking into consideration the views of the Examiner, give reasons for differing with the answer. In case a question has more than one correct answer, the committee will indicate the same in its report and if no answer is correct, recommendations to this effect will also be made by the committee. The committee will also point out the printing error(s) in questions and their key answers, if any, and make necessary recommendations. In such a way the result and its category-wise merit list will be declared/notified as per schedule.
- 6.3 The result of all the candidates appeared in the entrance test will be declared and made available on the website of the University. No detail marks cards will be sent to the candidates. The candidates may see their marks on the University Website. No separate intimation will be given to the candidates in this regard. There will be no rechecking/re-evaluation of the Answer-Sheet.
- 6.4 If two or more candidates obtained equal aggregate marks in the Entrance Test for admission to B.Sc. Medical Technology Course, then their inter-se ranking shall be determined on the basis of marks obtained by the candidates in Biology, Chemistry, and Physics in that order in the said entrance test. If the tie still persists after exhausting the above procedure, then the candidate older in age will be given preference. For Non-Medical stream candidates for B. Pharmacy Ayurved course Biology will be replace with Math. If the tie still persists then the preference will be given to the medical stream candidate for B. Pharmacy Ayurved course.
- 6.5 The combined and category-wise merit list based on the marks of the entrance test of all qualified candidates will be prepared and notified. The said merit list will be uploaded on the University website. Merely assigning the rank in this merit list does not confer

any right for admission. However, the admission will be made in order of merit as well as fulfilment of the prescribed eligibility criteria on verification of the original certificates/documents and further subject to availability of seat(s) in the concerned quota/category at the time of counselling.

# Chapter 7 GENERAL INSTRUCTIONS

### (7.1) INSTRUCTIONS FOR OMR ANSWER SHEET

- (7.1.1) The specimen copy of the **OMR Answer Sheet** which will be distributed along with the Question Booklet is given at **Annexure-I** of the Prospectus. Candidates are advised to go through it and be conversant with the requirement of filling up the particulars and marking the answers, so that during the examination they could do so without any difficulty and without making any mistake or loss of time.
- (7.1.2) The answer sheet used will be of special type, which will be scanned on optical scanners. There will be one side of the answer sheet for marking answers.
- (7.1.3) The candidate must ensure that the answer sheet is not folded. She should not make any stray marks on it.
- (7.1.4) Candidates are advised to bring with them a card board or a clip board so that they have no difficulty in writing responses in the Answer Sheet even if the tables provided in the Examination Hall may not have smooth surface. They will also bring their own Ball Point Pens (Blue/Black) of good quality. These will not be supplied by the University.
- (7.1.5) **Roll Number:** Write and mark your Roll number as per specimen answer sheet **Annexure-13**
- (7.1.6) For Roll Number and respective answers appropriate circles be darkened with Blue/Black ball-point pen only. Partially filled circles, dot matrix, X or tick marked circles shall be liable to be rejected by the machine. Darkening of circles/ovals be done correctly as indicated below for guidance

(7.1.7) **Writing of responses:** There will be four alternatives for each of the question numbering 001 to 100. Of these four responses only one will be the correct or the most appropriate response. The candidate will indicate her response to the question by darkening the appropriate circle/oval completely. For example Question No.008 in the Question Booklet reads as follows:

### Taj Mahal is situated in :

(A)Delhi (B)Bombay (C)Agra (D)Bangalore

The correct response to this question is (C) Agra.

The candidate will locate question No.008 in the answer sheet and darkened the circle/oval (C) as shown below:

If the candidate does not want to attempt any question, she should not touch the circle given against that question.

- (7.1.8) The candidates must fully satisfy themselves about the accuracy of the answer before darkening the appropriate circle as no change in answer once marked is allowed. Use of eraser or white fluid on the Answer Sheet is not permissible, as the Answer Sheets are machine gradable and it may lead to wrong evaluation
- (7.1.9) If more than one circle is darkened or if the responses are marked in any other manner it shall be treated as wrong way of marking and shall be rejected by the Scanner /University.
- (7.1.10) The candidate is advised to decide about the answer before she marks it on the answer sheet. She must ensure that the circle is completely darkened with blue/black ball pen only. A lightly or faintly darkened circle will be rejected by the optical Scanner/University

### (7.1.11) Important instructions for marking:

- Marks should be dark and should completely fill the circle.
- > Darken only one circle for each question.
- Make the marks only in the space provided.
- Please do not fold the answer sheet and make any ROUGH WORK thereon.

### (7.2) Instruction to be followed in the Examination Hall:

- (7.2.1) The Entrance Examination Hall will be opened 30 minutes before the commencement of the test. Candidates are expected to take their seats immediately after the opening of the Examination Hall. If the candidates do not report in time, they are likely to miss some of the general instructions to be announced in the Examination Hall.
- (7.2.2) The candidate must show, on demand, the Admit Card for admission in the Examination Hall. A candidate who does not possess the Admit Card downloaded from the University website shall not be admitted to the Examination Hall under any circumstances by the Centre Superintendent.
- (7.2.3) Calculators, Slide Rules, Geometry Box, Electronic Digital Watches with facilities of calculators, mobile phones, pagers or any other electronic gadget are

not allowed inside the Examination Hall.

- (7.2.4) The candidates will be given question booklet along with answer-sheet ten minutes before the commencement of the test.
- (7.2.5) The candidate will check and ensure that the Question Booklet contains number of pages as are written on the top of the first page and if any page is missing or misprint, the same be brought immediately to the notice of the Invigilator.
- (7.2.6) Immediately on receipt of the question booklet the candidates will fill in the required particulars on the cover page of the question Booklet with ball point pen only. They will deal with the booklet when asked by the Invigilator. Also the candidates will fill in the required particulars on the Answer Sheet.
- (7.2.7) The test will start exactly at the time mentioned in the Admit Card and an announcement to this effect will be made by the Invigilator.
- (7.2.8) During the examination time, the Invigilator will check Admit Card with the identification-cum-attendance sheet of each candidate to satisfy herself about the identity of the candidate. Admit Card will be retained by the candidate thereafter. The Invigilator will also put her signature in the place provided on the Answer sheet Admit Card and Identification-cum-attendance sheet.
- (7.2.9) Use Blue/Black Ball Point Pen only to darken the appropriate circle. Darken only one circle for each entry as the Answer once marked is not liable to be changed.
- (7.2.10) A signal will be given at the beginning of the examination and at the half-time. A signal will also be given before the closing time when the candidate must stop marking the responses.
- (7.2.11) After completing the test each candidate should check again that all the particulars required in the Question Booklet and Answer Sheet have been correctly written and thereafter the Answer Sheet will be handed over to the Invigilator by the candidate before leaving the examination hall. However, the Question Booklet and Admit Card will be retained by the candidate after the entrance test is over.
- (7.2.12) Candidates removing pages from the Question Booklet during the period of entrance test, impersonation or trying to appear in the counselling through forged means or by producing fabricated/tampered documents will be dealt with as per law.
- (7.2.13) The admit Card will be retained by the candidates after the Entrance Test is over. Candidates are advised to preserve their Admit Cards in good conditions till counselling/admission in Colleges is over.

- (7.2.14) The candidates are advised not to indulge in unfair means activities/malpractices which breach the examination rules. If any candidate is found to be indulged in any such activity, she shall be debarred from taking this examination in future and shall also be liable for criminal action or any other action deem fit by the University.
- (7.2.15) If a candidate is admitted in the College on the basis of the merit of the Entrance Test, but at a subsequent time, if it is discovered that she had used unfair means practice during the entrance test, the student shall be removed from the College and all the fees and other dues paid shall be confiscated. Further action as warranted against the candidate and her parents as per law may shall be taken.

# Chapter 8 COMMON/ CENTRALIZED COUNSELLING

Candidates are informed that each round of counselling is a separate round and the rules of each round are different. Once any round commences, the rules of that round will apply to all the candidates even if they were allotted/admitted in the previous round(s) of counselling. Once round 2 commence the rules of Round 2 shall apply and the rules of round 1 will not apply. Similarly, the rules of Mop-Up/Stray Vacancy round will apply only on that round.

All the candidates will have to compete amongst their own categories/sub- categories. The candidates of reserved categories, if selected by virtue of their general merit against the unreserved seats shall not exhaust the seats reserved for the concerned categories. However, the allotment of seats will be made college- wise depending upon the merit-cum-choice of the candidate(s) for the concerned college. Similarly, the sub-reserved categories candidates, if selected by virtue of their merit in main category shall not exhaust the seats reserved for sub-categories.

#### 8.1 Vacancies

### 8.1.1 Round 1 Vacancies

Candidates are informed that they will be shown the category-wise total number of seats in Round 1.

### 8.1.2 Round 2 or Subsequent Round Vacancies

- a) Clear-cut vacancies- These are the seats that were either not allotted in Round 1 or have remained vacant due to non-admission by the allotted candidates. Vacancy position of these seats shall be displayed prior to the start of the 2<sup>nd</sup> or subsequent rounds of counselling.
- **b) Virtual Vacancies-** These vacancies are not displayed in the vacancy position list, as they may arise due to upgradation of candidates during the second or subsequent rounds of counselling.

Hence, it is not mandatory to fill only those choices/preferences which are reflected in the vacancy position of seats. Therefore, candidates are advised to fill the preferences/choices of colleges as per their choice. The seats in 2<sup>nd</sup> round or subsequent round will be allocated as per availability of seats in order of merit- cum - choice/preference submitted by the candidate

### (8.2) **Round -1 (Start & End)**

- (8.2.1) Exercising of choices/preferences of Colleges and Quota and locking of choices by clicking Click on the **Submit** button. Therefore, candidates are advised to take care while filling up the orders of choices/preferences of College(s) and Quota.
- (8.2.2) The seats in first round will be filled category-wise.
- (8.2.2) Process of Seat Allotment Round-1
- (8.2.3) Publication of Allocation list of Round-1on AMRU website.
- (8.2.4) Download provisional admission letters of round 1 from the website of the university after login to their account.
- (8.2.5) Physical Reporting at the allotted nursing college/ Institutes with Provisional allocation letter, print out of application form and original documents against Round -1 (one).
- (8.2.6) Candidates who have been allotted a seat in round one (1) can opt for free exit and can directly participate in round two.
- (8.2.7) Candidates who have been allotted a seat in round one (1) can upgrade from round 1 to round 2 only after physical reporting at college/institute
- (8.2.8) If a registered candidate is not allotted a seat in round one (1), he can participate in round 2 directly
- (8.2.9) Candidates willing to upgrade from Round 1 to Round 2 have to report at the allotted institute/college with original documents of round 1 and complete the admission formalities. During the completion of admission formalities, if the candidate wishes to upgrade then he/she has to give willingness for upgradation in the college
- (8.2.10) After the last date of Round 1 admissions, the provisional allocation letter will be automatically cancelled and candidate does not take admission at the allotted or any other institution using this letter.

### Round -1 (End)

### (8.3) **Round -2 (Start)**

- (8.3.1) Fresh Choice filling and locking of choices for Round-2. by clicking Click on the **Submit** button. Therefore, candidates are advised to take care while filling up the orders of choices/preferences of College(s) and Quota.
- (8.3.2) It is pertinent to mention here that the candidates can fill the choices of colleges categories /quota which are not reflecting in the vacancy position of seats during 2<sup>nd</sup> round of Counselling as few seats may arise due to changeover of college by candidates who have already occupied a UG (B. Sc Nursing) seats in 1st round. In view thereof, seats of any College may become vacant in 2nd round due to above mentioned changes. Hence, it is not mandatory to fill only those choices/preferences which are reflected in the vacancy position of seats. Therefore, candidates are advised to fill the preferences/choices of colleges as per their choice. The seats in 2nd round will be allocated as per availability of seats in order of merit- cum choice/preference submitted by the candidate.
- (8.3.3) Up-gradation from one Nursing College to another shall be allowed during the 2<sup>nd</sup> round of Centralized /Common Counselling in order of merit as per the availability of seats and choices filled by the candidates. During the 2<sup>nd</sup> round of Counseling, if an admitted candidate of round -1, who participated in 2<sup>nd</sup> round is not getting up-gradation then he/she will be allowed to retain the seat with category allotted in Round-1 and hence allocation shall be done only of available vacancy in Round-2. The vacant seats in second round will be filled category-wise.

The Himachali Bonafide candidates who fulfil the eligibility criteria of State Quota seat as prescribed in the Prospectus, admitted under management quota in the private Nursing College can also be up graded to the State Quota Seat during the 2nd round of Counseling, if she applied for the state quota seat in the Colleges concerned against vacant/drop- out seats, if any, in order of merit as the case may be, subject to fulfilment of the eligibility criteria as prescribed for State Quota seats.

### (8.3.4) **CONVERSION ALGORITHM** (applicable in 2<sup>nd</sup> round)

At the end of 2nd round of Common/ Centralized Counseling, in case, the eligible candidate to the extent of reservation in any category are not available or seats remain unfilled, the vacant seats shall be filled up by making them available to other category as given below:

### (A) For B.Sc. Medical Technology Course

- (i) In case suitable candidate is not available in any sub-category, the seat shall be offered to the respective main category and then to unreserved category. The vacant seats of SC/ST shall be offered to each other before they are offered to unreserved category.
- (ii) The candidature of SC/ST candidates belonging to other state (non- HP) will only be considered for General category by virtue of their General combined merit for allocation of State Quota seats.

- (iii) For allotment of seats which are earmarked for Ex-service man/wards of Ex-serviceman, first preference will be given to ex-service man in order of merit and if ex-service man is not available than wards of ex-service man will be considered based on the priority as described in Appendix-5
- (iv) If the In- Service candidate is not available the seat shall be converted to the Direct Category and will be filled up as per reservation roster point.

#### (B) For B. Pharmacy (Ayurved) Course

(i) In case, any seat (s) remains unfilled in a particular reserved category of any group, the same shall go to respective reserved category of other groups horizontally. If no candidate of any reserved category is available in any group the same shall go to general category of respective group, failing which the seat (s) shall go to Group-I General category. However, the seats reserved under each group will be inter-changeable if sufficient number of SC/ST candidates is not available in the same category of respective group, provided that the total number of seats remains the same for each group. The unfilled unreserved seats of Group-I will also be filled from among the candidates of Group-I (a) General (UR) Category.

For B.Pharmacy (Ayurveda) course, minimum number of selected female candidates excluding those female selected under reserved categories shall be five. In case of short fall, female candidates in order of merit shall be considered for admission

Note: The seats once converted to "unreserved" in  $2^{nd}$  round will be allotted on the basis of open merit in all subsequent rounds

- (8.3.5) Publication of result of Round-2 on AMRU website.
- (8.3.6) Download provisional admission letters of round 2 from the website of the university after login to their account. Please note that after the last date of Round 2 admissions, the provisional allocation letter will be automatically cancelled and candidate does not take admission at the allotted or any other institution using this letter
- (8.3.7) If a candidate is not allotted a seat in round 2, he/she can participate in mop-up round.
- (8.3.8) Candidates getting upgraded in Round 2 Shall NOT have any claim on Round 1 seat whether he/she take admission or not.
- (8.3.9) Those candidate get up-gradation or changed category or changed quota seat in 2<sup>nd</sup> round. Such candidate must get fresh online generated allotment letter for the changed category or quota seat and required to take admission against allotted college, Category/Quota otherwise the allotted seat will be cancelled due to non-admission.

### (8.4) (Mop up round) (Start)

- (8.4.1) Fresh Choice filling and locking of choices for Round-2. by clicking Click on the Submit button. Therefore, candidates are advised to take care while filling up the orders of choices/preferences of College(s) and Quota.
- (8.4.2) No up gradation of Specialty/Category within College or from one college to another college shall be made during the Mop up round of Counselling by the Counselling committee
- (8.4.2) Process of Seat Allotment Mop Up Round. It is clarified here that since all the remaining seats had already been filled after converting them to un-reserved category, based on merit -cum- preference, the vacancy of category will only arise if the candidate allotted seat under some reserved category does not join. At the end of Stray round of Common/Centralized Counselling, the remaining reserved seats will be converted to unreserved as per Counselling procedure like in 2<sup>nd</sup> round (Clause 8.3.4).
- (8.4.3) Publication of result of Mop up round on AMRU website.
- (8.4.4) Download provisional admission letters of mop up round from the website of the university after login to their account. Please note that after the last date of Mop up round admissions, the provisional allocation letter will be automatically cancelled and candidate does not take admission at the allotted or any other institution using this letter
- (8.4.5) Physical Reporting at the allotted nursing college/ Institutes with Provisional allocation letter, print out of application form and original documents against Mop-Up round
- (8.4.6) Those candidate get up-gradation or changed category or changed quota seat in Mop up round round. Such candidate must get fresh online generated allotment letter for the changed category or quota seat and required to take admission against allotted college, Category/Quota otherwise the allotted seat will be cancelled due to non-admission.

### (8.5) Stray Vacancy Round (If Required)

(8.5.1) Separate schedule and Rule of Stray round counselling (if any) shall be uploaded on the University website www.amruhp.ac.in Therefore; the candidates are advised to remain in touch regularly with the University website. admission and Counselling Committee shall in no way be responsible for non- communication on this account.

### **Stray Vacancy Round (End)**

- (8.6) The final eligibility of the candidates shall be determined after verification of all original documents strictly as per provisions of the prospectus by the Scrutiny Committee constituted by the Principal of the concerned Nursing College. However, it will be the entire responsibility of the candidates concerned to supply correct and authenticated information on the online Application form. The Application Forms of ineligible candidates will be rejected by the Common /Centralized Counseling Committee. No request for change of category once opted/filled in the online Application Form after issuance of category- wise merit list during the course of Online Counselling will be entertained under any circumstances. It is further clarified that the candidates will be allocated seats provisionally on the basis of their merit rank-cum-choices/preferences. As far as their final eligibility is concerned, the Counselling Committee shall, in no way be responsible, if they are found to be ineligible at the time of admission in the allocated college, leading to cancellation of their seat or any other consequence emanating from the same.
- (8.7) It will be the sole responsibility of the Principal of the colleges concerned to admit the eligible candidates to the course as per provisions of the Prospectus. The Principal must ensure that he/ she is clear about the prescribed eligibility criteria of the State Common /Centralized Counselling Prospectus-2025-26 before admitting the candidate to the course. Candidates are also requested to ensure that they are eligible for the course they are going to take admission. In the event of his/her ineligibility detected at later stage, his/her admission shall be cancelled without any notice. Any wrong or misleading entry or documentation in the form will lead to the rejection of the candidature at any stage without assigning any reason for which the candidate(s) would be solely responsible along with its legal consequences and liabilities of entire course fee to the concerned institutions
- (8.8) Candidate who brings incomplete documents/certificate(s) at the time of reporting for verification of documents at the level of college for admission, his/her candidature is liable to be rejected without any notice by the College Scrutiny Committee.

# **Chapter 9 Joining, Medical and Migration**

#### 9.1 **JOINING TIME**

- 9.1.1 Selected candidates must join their respective courses on the date intimated to them at the time of selection or communicated to them in the selection letters. The selection of those who fail to join by the stipulated date shall automatically stand cancelled.
- 9.1.2 At the time of admission in the College, the candidates have to submit his/her Original Certificates. No candidate will be allowed to leave the course during midsession. Incase, admitted students wants to leave the course during midsession, then he/she is required to submit entire tuition fee for ongoing Academic Session failing which his/her certificates will not be released by the Principal concerned.
- 9.1.3 No stipend will be paid during the course.
- 9.1.4 Candidates will have to make their own arrangement to stay as no hostel is available.

### 9.2 MEDICAL EXAMINATION:

Medical fitness will be pre-condition for admission to any of the course. Selected candidates are medically examined by a Medical Board constituted for the purpose.

### 9.3 MIGRATION

No migration will be allowed in the B. Sc. Medical Technology Courses in any case.

- 10.2.1 Fees will be charged for full calendar year and not any part thereof. No notice will be displayed for depositing the college fees. It will be students responsibility to pay the dues in time. Failure to payall fee and other dues in fall by the last day of the September every year subsequently failing which by they are liable to a fine of Rs. 100 per day till fifteen days and there after automatically entail removal of the student name from the roll. He/She, however, may be readmitted on payment of arrearsof fees plus fine and readmission fee of Rs. 2000/- The Principal however is empowered to grant exemption of fine in deserving cases./
- 10.2.1 In case the last day happens to be a Sunday or a Holiday the fees shall be paid on the next workingday.
- 10.2.1 Presently, there is no hostel facility available for boys. Boys seeking admission will have to make their own arrangements for stay. But Girls Hostel for 36 students is available, which is mandatory, subject to availability of seats. Allotment will be on merit basis.
- 10.2.2 If a student leaves the college after one week of admission date and after depositing the dues there will be no refund of fee and the so vacant seat is filled up from waiting list, however if he leave within one week 20 % will be deducted and the rest of the amount will be returned to the student.
- 10.2.3 Securities will not be refunded if not claimed within three months after the declaration of the final result of the 8th semester. The security amount will not be refunded to the students if they leave the studies at their own in between the degree course/ without completing the course. If any students after putting six months or more leave the institute to join some other institution or

job in that case the society will suffer loss as the seat will remain vacant for coming years. To meet out these losses certain amount may be fixed to be charged from the candidate besides forfeiting his security deposits or the original certificates may be allowed to be retained in the college for at least three years and while the original certificates are demanded for joining other course the candidate should deposit at least the tuition fee for the ongoing Academic Session.


