## NOTICE

**Subject: Cancellation of Admission of Candidate Ms. Gagan Preet Kaur – MBBS/BDS Counselling 2025 in compliance of LPA No. 728 of 2025 and CMP No. 27312 of 2025.**

It is for information of all concerned that the following directions of the Hon'ble High Court of Himachal Pradesh are hereby notified for compliance in connection with the MBBS/BDS Counselling 2025:

1. **In CWP No. 12586 of 2025 dated 05.08.2025**, the Hon'ble Court permitted Candidate *Ms. Anjali Sharma*, Application No. 25013616 to participate in the counselling process as a **Priority-III** candidate, subject to the final outcome of the writ petition. Accordingly, she was allotted a seat in **Dr. Yashwant Singh Parmar Government Medical College, Nahan** in the 1st round of counselling.
2. **Vide order dated 25.08.2025**, the Hon'ble Court observed that only **one ward of a defense personnel who died while in service** can be considered under Priority-III. It was further directed that while both petitioners (*Ms. Anjali* and *Mr. Abhay Gautam*, brother and sister) may initially be considered under Priority-III, the benefit shall ultimately be extended only to one candidate based on merit or the options exercised. The other candidate would thereafter be considered under **Priority-VI**, with that right duly protected. In pursuance of this order, *Ms. Anjali Sharma* was removed from her allotment in the 2nd round, and the seat was subsequently allotted to *Ms. Gagan Preet Kaur*, Application No. 25010869.
3. **In CMP(M) No. 1797 of 2025**, the Hon'ble Court has now directed that, keeping in view the fact that the appellant *Ms. Anjali Sharma* had already been admitted in the said institute, she shall be **allowed to continue** in the institution. Consequently, the admission of *Ms. Gagan Preet Kaur* is required to be cancelled as per the orders of the Hon'ble Court.
4. It is further clarified that the **State Counselling Committee has no authority to admit students beyond the number of seats permitted by the National Medical Commission**

(NMC). Compliance with NMC-approved intake is mandatory, and no supernumerary or additional admissions can be made beyond the sanctioned capacity.

5. The last date for MBBS/BDS admissions for the Academic Session 2025-26 is 20th November 2025, as notified by the Medical Counselling Committee (MCC). Therefore, the correction in admission status must be completed by the said date.

In view of the above judicial directions and regulatory provisions, the Counselling Committee for MBBS/BDS decided in the meeting held under the Chairmanship of DME&R on 19.11.2025 at 10:00 AM that the admission of Ms. Gagan Preet Kaur stands cancelled w.e.f. 20.11.2025 at 01:00 PM. and Ms. Anjali will be admitted on that seat.
