As per the Atal Medical and Research University, Himachal Pradesh Regulations for Affiliation and Inspection of Colleges, Notification No. AMRU/GAD/AC/2022/Vol-I/4030-4033 dated 13.08.2024, and in accordance with the decisions taken in the meetings of the Finance Committee held on 31st January 2020, 07th July 2021, 10th January 2022, and 04th October 2022, as well as the decisions taken from time to time by the Finance Committee and the Academic Council, and with the subsequent approvals accorded by the Board of Management, AMRU, the Affiliation Fee Schedule for various courses for the Academic Session 2026–27 is hereby published as under, as duly approved by the Hon'ble Vice-Chancellor, AMRU.

- 1. Inspection process shall be started from 31st March 2026.
- 2. Application for affiliation along with affiliation fee will be accepted ONLINE through the official portal of AMRU/IUMS.
- 3. GST as applicable on total affiliation fees including late fees.
- 4. After receiving the online application for affiliation (complete application), the same will be processed by AMRU to grant the desired affiliation as per provision of Statute/Ordinance/Regulation of Affiliation and Inspection of Colleges.
- 5. The affiliation letter for a particular course will be issued only if the college has produced the valid permission of the concerning higher council/commission, if applicable and **submission of fees**.
- 6. No affiliation letter shall be issued unless the full prescribed fee has been submitted, subject to approval of the competent authority.

Other Conditions for Affiliation of AMRU

1. A new applicant college shall request the creation of a New Applicant College Login ID by sending an email to the Academic Branch of the University at acadmedicaluniv.mandi@gmail.com along with the requisite details such as official email ID, contact number, and **PAN** (in case of non-Government colleges/institutions).

2. The process of affiliation, including payment of Application, Affiliation, and Inspection Fees, shall be carried out through the IUMS Portal of the University. The applicant college should visit https://erpamruhp.in

3. The college is required to submit the *complete application form* on the IUMS portal of the University along with the prescribed fee. Incomplete or unpaid applications shall be summarily rejected.

4. After receiving the complete online application for affiliation, the same shall be processed by Atal Medical and Research University, Himachal Pradesh for granting the desired affiliation as per the provisions of the AMRU Regulations for Affiliation and Inspection of Colleges/Regulatory bodies

5. The Application Fee for seeking *Temporary/Provisional Affiliation* from applicant colleges for each course shall be non-refundable.

6. All colleges shall strictly follow the Ordinances and Statutes of the University. No affiliated institution shall discontinue any course without the prior approval of the University, as per the AMRU Regulations for Affiliation and Inspection of Colleges. An application for such approval shall be made to the Registrar, AMRU, by the Head of the Institution, duly forwarded by the Management, at least one full academic year in advance, clearly stating the reasons for the proposed closure and enclosing a copy of the Managing Body's resolution supporting the proposal.
