## **Notice for 2<sup>nd</sup> Stray vacancy Round (Walk-in) for B.Sc. Nursing, Post Basic B.Sc. Nursing and M.Sc (N) Counselling 2025**

As per the Indian Nursing Council Notification 13 of 2025 issued vide. F.no.1-6/LT/2025-INC dated 22.10.2025 the last date for admission in B.Sc. Nursing Program for academic year 2025-26 is as under:-

**For B.Sc. (N) The Universities/colleges of Nursing shall implement of B.Sc. (N) program semester wise. In the context, it is clarified that the students who are admitted upto 31<sup>st</sup> Oct, 2025 in B.Sc Nursing course shall be considered as REGULAR BATCH. The students admitted from 1<sup>st</sup> Nov 2025 onwards will be considered as IRREGULAR BATCH. Examination shall be conducted separately for the above batches. Universities shall ensure that institution shall comply with semester requirements as prescribed in the syllabi before the conduct of examination**

In view of above, the AMRU, Ner Chowk has decided to commence **Irregular Batch** as per the university notification No AMRU/Acad/Nursing/GNCSLBS/2025-7940-7959 dated 25.11.2025.

Therefore, it is informed that the 2<sup>nd</sup> Stray Vacancy Round of Counselling in physical mode for admission to B.Sc. Nursing (**Irregular Batch for Private colleges only**) will be conducted on **29.11.2025 from 10:00 AM onwards**. In addition to that on the **same day, the 2<sup>nd</sup> Stray Round of counselling for Post Basic B.Sc. Nursing and 1<sup>st</sup> Stray Round of M.Sc. Nursing courses will also be conducted** at the Auditorium, SLBS Government Medical College Complex, Atal Medical & Research University, HP, Nerchowk, Mandi.

Eligible and interested candidates/authorized representatives, who are not admitted in any Government/Private Nursing institute of Himachal Pradesh, and meet the eligibility criteria as per the B.Sc. Nursing(N), Post Basic B.Sc.(N) and M.Sc (N) Nursing Prospectus-2025, are advised to participate in the counselling with all original documents.

**For vacancies in Government Nursing Colleges in Post Basic B.sc Nursing and M.Sc (N) course, candidates currently admitted in Private Nursing Institutions will also be eligible.**

The latest vacancy status will be uploaded on the University's website. Only those candidates/authorized representatives whose names appear in the merit lists of B.Sc. Nursing, Post Basic B.Sc. Nursing and M.Sc (N) issued by AMRU, HP, shall be permitted to attend the counselling. Candidates/authorized representatives reporting up to 11:00 AM will be considered for seat allotment strictly as per the merit of the Nursing Entrance Examination-2025 held on 11.06.2025.

**Note:** Candidates must present their Nursing Entrance-2025 application form and original documents, and deposit the full admission fee on the spot. Online payment facility will be available.

**NOTIFICATION**

It is hereby notified for information of all Principals of affiliated Nursing Colleges, students, and stakeholders that the University has decided to start the **Irregular Batch for the B.Sc. Nursing (4-Year Degree Programme)** in the private colleges affiliated with Atal Medical and Research University, Nerchowk, Distt Mandi, HP (AMRU) for the Academic Session 2025-26 in consonance with Indian Nursing Council, New Delhi (INC) Notification No. 13 of 2025 dated 22-10-2025.

The following Guidelines shall govern the admission and academic conduct of the Irregular Batch for private nursing colleges under AMRU as per INC directions.

**Guidelines regarding admission for the B.Sc. Nursing Programme for the IRREGULAR BATCH in private Nursing colleges under AMRU as notified by Indian Nursing Council, New Delhi.**

**1. Batch Timing**

- 1.1 The Irregular Batch shall run six (06) months behind the Regular Batch in all academic and examination activities.
- 1.2 A separate academic calendar and examination schedule will be issued by the University.

**2. Classification of Students into Irregular Batch**

- 2.1 All admissions granted from the date of issue up to the date of notification by the Indian Nursing Council, New Delhi, shall be treated as *Irregular Batch* admissions.
- 2.2 Students admitted during this period will:

- a) Follow the Irregular Batch academic calendar.
- b) Attend classes and clinical postings scheduled specifically for the Irregular Batch.
- c) Appear in the **Irregular Batch examination cycle**, which will be held six (06) months after the regular batch examinations.
- d) No student admitted during this period shall be merged with the regular batch under any circumstances.

### 3. Compliance by Affiliated Colleges

3.1 All affiliated Nursing Colleges are instructed to:

- a) Maintain a separate attendance register for the Irregular Batch.
- b) Prepare and display the Irregular Batch timetable for theory, practical, and clinical postings.
- c) Ensure full completion of INC-mandated teaching hours and clinical requirements for the Irregular Batch.
- d) Submit the list of students admitted to the Irregular Batch to the University within 5 days of admission.

### 4. Important Note

- 4.1 Admissions made beyond the period notified by the Indian Nursing Council, New Delhi, shall not be permitted for either the Regular or Irregular Batch without prior approval of the University and in accordance with INC norms.
- 4.2 No relaxation in attendance, clinical hours, or examination eligibility will be provided to the Irregular Batch.

All concerned are hereby directed to comply with the above instructions with immediate effect.
