Sub: Revised cut-off scores of NEET-PG 2025 after lowering of qualifying percentiles

1. The result of NEET-PG 2025 was declared on 19th August 2025. In accordance with the directions of the Ministry of Health & Family Welfare, Govt. of India vide letter No. U-12021/11/2025-MEC (FTS- 8363852) dated 09.01.2026, the minimum qualifying percentile cut-off for counseling of the third round of NEET-PG 2025-26 for various categories of candidates has been reduced.
2. Accordingly, the revised qualifying percentiles for NEET-PG 2025, for the academic session 2025-26, are as follows:
