Candidates who have already applied in response to the earlier notification are not required to apply again.

- **Date of Entrance Test:** 25.02.2026 (11:00 AM)

### **Important Instructions:**

1. Only candidates possessing the Degree or Provisional Degree are eligible to appear in the Entrance Examination. Candidates must submit self-attested photocopies of the Degree/Provisional Degree along with the Admit Card at the examination center.
2. Candidates who do not possess a valid NOC issued by the Director of Health Services, Himachal Pradesh shall not be allowed to participate in the counselling process.
3. Candidates are required to submit their latest Service Certificate in the office of the Director of Health Services (DHS), Shimla on or before 17.02.2026. Candidates who have already submitted their latest Service Certificate to the DHS office are not required to submit it again.
4. The Director of Health Services shall not issue NOC to candidates who have not submitted their latest Service Certificate.
5. The candidate whose NOC Not received from the DHS, Shimla will not be allowed to appear in the counselling process.
6. The final vacancy position shall be displayed at the time of counselling.
7. The date of counselling shall be notified on the day of the Entrance Examination.
8. Candidates are advised to regularly visit the University website for updates and further information.

### NOTIFICATION

In continuation and partial modification of this Department notification of even no. dated, HFW-B-B015/11/2023, dated, 10-10-2025, vide which new Resident Doctor Policy, 2025 was notified, the Governor of Himachal Pradesh is pleased to incorporate the following provisions in Resident Doctors Policy with immediate effect, in the public interest as under:-

1) The prescribed ratio for the total number of seats of Senior Residents /Tutors (Specialist) in each Medical College/Institution shall be distributed in the ratio of 66.66% :33.33% as under:-

- For in service GDO/MO=66.66%
- For direct candidates =33.33%

For the purpose of maintaining the prescribed ratio of 66.66%:33.33 % between the GDO/MO and direct candidates roster shall be prescribed by AMRU.

Further the distribution of seats will be interchangeable in case of non availability of candidates in their respective Group/Category i.e GDO/MO candidate by direct candidate or vice versa.

2) The number of seats so sanctioned of Senior Resident/Tutor (Specialists) for filling up in Non Clinical Specialties /departments for Senior Resident/Tutors Specialists for IGMC Shimla and Dr. RPGMC Tanda in no case shall exceed as which has been prescribed by the NMC.


