NOTICE FOR INTERNHISP FOR FMG FOR SESSION 2026-27

The Applications through online mode are invited from only Bonafide Himachali Foreign Medical Graduates who have qualified Foreign Medical Graduate Examination conducted by National Board of Examinations in Medical Sciences, New Delhi for Compulsory Rotatory Medical Internship in Government Medical Colleges affiliated with Atal Medical and Research University, HP for the session 2026-27. Candidates may submit the online application form through the University's website from 18.03.2026 onwards, and the last date for submission of applications is 07.04.2026. Important Information:

1. The seat allocation shall be done through centralized Counselling strictly on the basis of merit drawn on the basis of marks of Foreign Medical Graduate Examinations being conducted by National Board of Examinations in Medical Sciences, New Delhi-cum- choice of College filled-up by the candidates in the online application form.

2. If the marks obtained in the NBE exam are same, the candidate who appeared in NBE exam on an earlier date shall be placed higher in the merit.
3. If both the above criteria are same, the candidate born earlier shall be placed higher in merit.
4. A combined merit list of all applicants of Himachali Bonafide shall be prepared.
5. The duration of internship will be decided by H.P. Medical Council, Shimla after seat allocation
6. The Bonafide Himachali Foreign Medical Graduates who are already doing internship in State Medical Colleges are not required to apply, for 2nd year / 3rd year duration of internship as they shall continue in the same place till completion of their required Internship duration.
7. At present there is no provision for stipend to FMG Interns in Govt. Medical Colleges. However, the Government of HP shall decide on the issue of provision of stipend to FMG Interns.
8. After allocation of seats the Candidates shall be required to apply for registration with H.P. Medical Council Shimla before joining the allocated college. The candidate shall report to the allocated colleges with Provisional Allocation letter and Provisional HPMC registration letter and other original documents. The reporting date to the allotted college will be notified separately. If the candidate does not report within stipulated time to the allocated college, the seat shall be offered to the next candidates of merit.
9. If the candidate allocated seat does not join the college, he/she will be removed from the list and will not be offered any seats in this academic session.
10. The Online application fees shall be Rs.25000/-
11. The seat allocation list shall be displayed on AMRU website. The candidates are requested to remain in touch with the website till the process is completed.
12. The last date for receipt of online applications is 07.04.2026 upto 02:00 PM.
13. Fees once paid shall not be refunded in any circumstance.

14. No fee shall be charged for doing internship in any college but if the government of Himachal Pradesh decided to change the fees in future the candidate will have to pay it. The candidate may be asked by the concerned institute to submit an affidavit in this regard.
15. The AMRU, Ner Chowk may call any candidate at any stage with documents for verification of credentials.

Note: Candidates may opt for Deendayal Upadhyay Zonal Hospital and Netaji Subhash Chander Bose Government Zonal Hospital while filling their choices; however, these options shall be considered only subject to approval of these hospitals for FMG Internship Training by the National Medical Commission. The availability of seats in these hospitals will be notified only after such approval is received. Preferences for these hospitals/colleges will be processed only upon receipt of approval. In the event that approval is granted after the completion of seat allocation, such seats will be offered exclusively to candidates who remain unallotted, and the choices of candidates who have already been allotted seats will not be considered.
