NOTIFICATION

Subject: Deferment of a portion of salary for a period of six months.

The Governor, Himachal Pradesh in view of the prevailing financial circumstances and in the interest of prudent fiscal management, in exercise of the powers conferred under proviso to Article 309 of the Constitution of India, is pleased to order temporary deferment of a portion of the monthly salary of certain categories of government employees for a period of six (6) months, effective from the salary of April to be paid in May, 2026.

The details of the deferment are as follows:

1. 30% of the salary shall be deferred in respect of:
 - Chief Secretary
 - Additional Chief Secretaries
 - Principal Secretaries
 - Director General of Police
 - Additional Director General of Police
 - Principal Chief Conservator of Forests (HOFF)
 - Principal Chief Conservator of Forests
 - Additional Principal Chief conservator of Forests

2. 20% of the salary shall be deferred in respect of:
 - Secretaries
 - Heads of Departments
 - Inspector General of Police
 - Dy. Inspector General of Police
 - Sr. Superintendent of Police
 - Police Officers upto the level of SPs
 - Chief Conservator of Forests
 - Conservator of Forests.
 - Other Forest Officers upto the DFOs level.



3. The payable and deferred components of salary shall clearly be reflected in the e-salary system and pay slips to ensure transparency.
4. The deferred portion of salary shall be reckoned for all purposes like pensionary benefits, leave encashment etc. as per relevant rules.
5. Statutory deductions including income tax, NPS/UPS/GPF contributions etc. shall continue to be regulated as per the applicable rules on full amount only to avoid future accounting issues. Deferment amount will be calculated on the Salary net of tax paid, NPS/UPS/GPF contribution, other fixed deductions.
6. Boards, Corporations, PSUs, Autonomous Bodies, Universities and other major Societies that receive Grant-in-aid or any kind of budgetary support from the State government shall also adopt this decision in line with the Government.
7. In respect of employees who are servicing loan installments, the following provisions shall apply:
 - Such employees may submit an undertaking to the Drawing and Disbursing Officer (DDO) in the prescribed format, as enclosed.
 - Upon submission of the undertaking, the deferment shall be calculated on the pay remaining after deduction of the loan installments amount.
8. The deferred portion of the pay shall not be treated as a deduction and will be released at a later date, as may be decided by the Government, based on the financial position of the State Government.
9. This measure is temporary in nature and is being undertaken as a collective effort to manage financial resources efficiently. All Departments are directed to ensure strict compliance with these instructions.


