



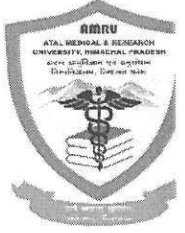

7. Application form submitted online/offline.
8. Valid photo identity proof

Candidates are advised to ensure that all documents are complete and valid at the time of verification.

In case any candidate is unable to attend the counselling personally due to unavoidable circumstances, he/she may authorize a representative through a duly signed authority letter. The authorized representative must produce all original document of the candidate at the time of counselling for verification purposes.

- Seats/posts shall be allocated strictly on the basis of merit-cum-eligibility determined during documents verification and counselling.
- Mere participation in counselling does not confer any right to selection or appointment.
