

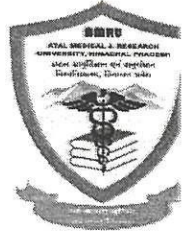

NOTICE REGARDING STATE COMMON/CENTERALIZED ONLINE COUNSELLING FOR POST BASIC B.SC NURSING COURSES FOR THE SESSION 2026-2027 NOC-CUM-ELIGIBILITY CERTIFICATE THEREOF IN R/O IN-SERVICE CANDIDATE.

It is hereby informed to all concerned that the process of State Common/Centralized Online Counselling for filling up In-Service Quota seats in Government Nursing Colleges of Himachal Pradesh for admission to Post Basic B.Sc Nursing Courses for the academic session 2026-27 is likely to commence shortly.

Accordingly, all eligible In-Service candidates of the State of Himachal Pradesh who intend to participate in the State Common/Centralized Counselling process are advised to obtain a **Provisional NOC-cum-Eligibility Certificate** from the competent authority in the prescribed format and upload the same while submitting the online application form.

The following instructions shall be strictly followed:

1. In-Service candidates must apply for a **Provisional NOC-cum-Eligibility Certificate** from the **Directorate of Medical Education & Research (DME&R), Himachal Pradesh**, or the **Directorate of Health Services (DHS), Himachal Pradesh**, as applicable through proper channel.
2. It shall be mandatory for all In-Service candidates to upload the Provisional NOC-cum-Eligibility Certificate at the time of submission of the online application form.
3. Only those In-Service candidates who upload a valid Provisional NOC-cum-Eligibility Certificate issued by DME&R or DHS shall be considered eligible for participation in the counselling process.
4. Mere possession of a Provisional NOC-cum-Eligibility Certificate shall not confer any right to admission. Candidates shall be required to obtain and produce the **Final NOC** from the competent Government authority at the time of admission.
5. In case a candidate who has been allotted a seat fails to produce the Final NOC at the time of admission, the allotted seat/admission shall be liable to be cancelled forthwith and without any further notice.
6. The prescribed **Proforma for Provisional NOC-cum-Eligibility Certificate** is enclosed as **Annexure-I**
7. The candidates must have completed minimum 5 years service on the last date of submission of application form, as initially notified. Any extension of the closing date shall not be taken into account for determining eligibility.

All concerned candidates are, therefore, advised to initiate the process for obtaining the Provisional NOC-cum-Eligibility Certificate well in advance to avoid any inconvenience at a later stage.
