## **Notice Regarding Submission of Valid Certificates by Candidates Applying for B.Sc (N), Post Basic B.Sc (N) and M.Sc(N) Courses Entrance Examinations– Session 2026–27**

All candidates applying for entrance Examinations for B.Sc (N), Post Basic B.Sc (N) and M.Sc(N) Courses for the Academic Session 2026–27 are advised to ensure that they possess valid certificates, wherever applicable, in the prescribed format available in the prospectus of Entrance Examination for B.Sc (N), Post Basic B.Sc (N) and M.Sc(N), before the counselling/admission process.

Candidates claiming reservation or any other benefit under the applicable provisions of the Prospectus shall be required to produce the original valid certificate(s), at the time of online application/counselling/admission or whenever called upon by the University. Failure to produce the requisite valid certificate(s) shall result in denial of the claimed benefit, in accordance with the provisions of the Prospectus and the applicable rules.

Please note that candidates claiming reservation under the Economically Weaker Section (EWS) category are specifically advised to produce a valid EWS Certificate for the financial year 2026–27, issued by the competent authority, certifying eligibility under the prescribed income limit of ₹4.00 lakh or below, as provided in the B.Sc (N), Post Basic B.Sc Nursing and M.Sc(N) Prospectus 2026–27 at the time of online application/counselling/admission.

Candidates must also ensure that they fulfil the eligibility conditions laid down in the Prospectus 2026–27 for B.Sc (N), Post Basic B.Sc Nursing and M.Sc(N) Courses. The University shall not be responsible if a candidate fails to produce the requisite certificate(s) at the time of counselling/admission it may result in cancellation of the candidature at any stage of the counselling/admission process.
